### **Lawrence Retirement Board Minutes**

## August 29, 2019

The Lawrence Retirement Board held its regular monthly meeting on August 29, 2019. Chairman Bateman was present with members Loughlin, Ceballos, Cuddy and Rizzo. The meeting was called to order at 8:42 AM.


